# **Program Description**

Presented in lecture format, this course reviews topics for the National Certification Corporation (NCC) Inpatient Obstetric Nursing Exam. Elements of the exam will be discussed, followed by a review of the content. The major components include disease processes during pregnancy, fetal evaluation, application of fetal monitoring for the laboring client and postpartum and neonatal assessments. Practice questions will enable the participant to increase confidence and experience with test content.

This program prepares the learner to:

- 1. Describe the Inpatient Obstetric Nursing Exam, test plan and the practice requirements to sit for the exam.
- 2. Construct a study plan for the exam based on understanding the blueprint and domains of practice covered.

# **Topics Covered**

# **1** About the Test, Test-Taking Skills and Disease Processes

#### Module Description

This module will introduce participants to the National Certification Corporation (NCC) subspecialty exam in inpatient obstetric nursing. General test-taking skills will also be reviewed. In addition, this module will describe disease processes that affect the obstetrical patient.

#### Module Learning Outcomes

This module prepares the learner to:

- 1. Describe the format and qualifications for the NCC subspecialty exam in inpatient obstetric nursing.
- 2. List general test-taking strategies.
- 3. List maternal disease processes that will affect both mother and baby during the pregnancy and labor process.

# 2 Pregnancy Risks

#### **Module Description**

This module discusses risks of pregnancy and implications on the mother and fetus. Psychosocial and environmental factors, domestic violence and illegal substances will be reviewed.

#### Module Learning Outcomes

- 1. List medical conditions of the mother, and understand the implications on the pregnancy.
- 2. Recite the known effects of domestic violence upon pregnancy.
- 3. Describe maternal, psychosocial and environmental factors that affect pregnancies.
- 4. Name illegal substances that are abused by the pregnant mother and the implications on the pregnancy.

# **3** Antepartum Assessment

#### Module Description

This module discusses features of antepartum assessment, including fetal heart rate (FHR) monitoring, ultrasounds, genetic testing and carrier screening.

#### Module Learning Outcomes

This module prepares the learner to:

- 1. Describe methods of antenatal testing.
- 2. Define a reactive nonstress test (NST).
- 3. Discuss the importance of biophysical profile (BPP) outcomes.
- 4. List the recommendation for prenatal testing by the American College of Obstetricians and Gynecologists (ACOG).
- 5. Describe the use of Doppler flow studies and results.

# 4 Electronic and Nonelectronic Fetal Monitoring

#### **Module Description**

This module discusses all aspects of electronic and nonelectronic fetal monitoring, including definitions and descriptions of fetal monitoring strips.

#### **Module Learning Outcomes**

- This module prepares the learner to:
- 1. Describe fetal monitoring patterns.
- 2. Describe the physiology of fetal heart rate (FHR) patterns.
- 3. Name categories of FHR strips.
- 4. Analyze cord gas samples to assist in interpreting outcomes for neonates.

# 5 Physiology and Management of Labor

#### Module Description

This module describes the physiology of labor, including the different stages and phases. Obstetrical complications, methods of induction, pharmacology of oxytocin and pain management will also be explored.

## Module Learning Outcomes

This module prepares the learner to:

- 1. Discuss methods of operative vaginal deliveries.
- 2. List obstetrical complications and their implications on labor and delivery.
- 3. Discuss methods of induction, along with timing of delivery.
- 4. Recite the pharmacology of oxytocin (Pitocin) and its proper use in labor and delivery.
- 5. Analyze the pain management methods in labor and delivery.

## **6** Obstetrical Procedures

#### **Module Description**

This module discusses obstetrical procedures utilized during labor and delivery. It also discusses the use of oxytocin (Pitocin), along with methods of pain control in labor.

#### Module Learning Outcomes

This module prepares the learner to:

- 1. List obstetrical complications and their implication on labor and delivery.
- 2. Recite the pharmacology of oxytocin and its proper use in labor and delivery.
- 3. List the methods of pain control utilized in labor and delivery.

# **7** Obstetrical Complications

#### **Module Description**

This module discusses obstetrical complications during the labor and delivery period. It also discusses complications that arise in the immediate postpartum period.

#### **Module Learning Outcomes**

This module prepares the learner to:

- 1. List complications that occur during labor and delivery.
- 2. Discuss nursing interventions for those complications of labor and delivery.
- 3. Explain the risk to the fetus during obstetrical complications.
- 4. List the potential complications from multigestational pregnancies.
- 5. Discuss prolonged pregnancy and the implications for the fetus and mother.

# 8 Postpartum

#### **Module Description**

This module discusses the postpartum period, along with complications and nursing interventions. Also reviewed will be body system changes and postpartum hemorrhage, along with lactation and parental education on newborn feeding.

#### **Module Learning Outcomes**

This module prepares the learner to:

- 1. Differentiate normal and abnormal conditions of the postpartum period.
- 2. Discuss body system changes in the postpartum period.
- 3. Explain the risk factors for postpartum hemorrhage.
- 4. Differentiate QBL vs. EBL.
- 5. Discuss lactation and parental education regarding newborn feeding.

# 9 The Newborn

## **Module Description**

This module looks at the newborn infant, identifying normal findings. It will also provide a systemic review of abnormalities and their implications on nursing care for the infant.

#### Module Learning Outcomes

- 1. Explain the newborn's transition to extrauterine life utilizing a body systems approach.
- 2. List possible complications of the newborn.
- 3. Differentiate the types of thermoregulation utilized by the newborn.
- 4. Identify newborns of mothers with substance-abuse issues.

#### **Module Description**

This module discusses professional issues regarding research, staffing, safety and legal implications of the obstetrical nurse, including top sentinel events.

#### Module Learning Outcomes

This module prepares the learner to:

- 1. Define important terms regarding professional nursing practice.
- 2. Understand the types of research available to nurses.
- 3. Explain the top sentinel events the occur in a labor and delivery unit.
- 4. List the top legal issues in obstetrical nursing.
