OVERVIEW

Have you ever wanted to go for a long hike but feared you couldn't do it alone? Have you and a friend ever wanted to go for a walk in the woods but were afraid of bears, bugs, big noises, bad bellies, or blisters? Have you thought about what you would do if you were hiking in a remote area and found a person wandering aimlessly, confused and bleeding? If these questions intrigue you, this first aid course is for you! In this course, we will offer hands-on experience in order to best support your leadership development and decision-making skills using our "Wilderness Olympics" format.

LEARNING OUTCOME

At the conclusion of this course, (at least 75% of) participants, using a systematic assessment and decision-making process, will be able to confidently care for themselves and/or distressed people in a wilderness or austere environment.

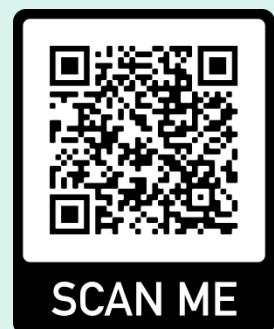
ABOUT THE COURSE AND VENUE
