OVERVIEW

This two-hour interactive, skills-based session gives clinicians of any discipline a talking map for effective, efficient goals of care conversations.

Led by Dartmouth Health Serious Illness Care Program faculty, the session features active learning and reflection, including progressive skills practice. Participants will leave the session with the skills and tools to begin having these conversations with their patients.

To maximize time for skills practice, prior to the session participants will be expected to: watch a short video (8 minutes) and to print out training materials.
